CONDITION: Items must be in good to like-new condition, meaning:

- Gently Used | Clean, stain-free, and odor-free
- Fully functional (zippers, snaps, buckles, poles, etc. must work)
- No damage such as excessive wear, holes, fraying, or missing components

BRAND REQUIREMENT: We only accept items made by reputable outdoor brands known for performance and quality (e.g. Patagonia, Arc'teryx, Osprey, MSR, etc.). Fashion, or non-outdoor-specific brands will not be accepted.

SEASONALLY APPROPRIATE: We will accept summer-specific (e.g. tanks, shorts) and winter-specific items (e.g. heavily insulated parkas, gloves) during specific dates only. Summer items: Jan 15 - Sept 1, Winter items: Sept 1 - Jan 15.

DECLINED ITEMS: Acceptance is at the sole discretion of Backcountry North. Items that do not meet our criteria for consignment must be picked up within 7 days of being notified. After 7 days, items will be donated to charity.

PRICING: Accepted items will be priced by Backcountry North using our internal pricing program, based on original retail price (MSRP), brand, item category, and condition.

- Items will be listed for **90 days at full resale price**.
- If unsold after 90 days, the item will be discounted 20% and listed for an additional 30 days.
- If unsold after 120 days, the customer will be notified to pick up unsold items.

UNSOLD ITEMS: Unsold items must be picked up within 7 days of being notified. After that, they will be donated to charity.

CONSIGNOR PAYOUT: Payouts are a percentage of the final sale price of sold items (selection made in initial contract).

- **50% via Check** issued once per month (for items sold in the previous month)
- 65% via Consignment Credit issued and available to use bi-monthly

Backcountry North Consignor Intake Worksheet

Backcountry North prices consigned items, taking into consideration product type, brand, condition, and original MSRP. If you choose, you may use this worksheet to list your items and set your minimum acceptable price. **NOTE: If our price comes in lower than your min price, we'll simply decline the item.** Keep in mind, items not sold in 90 days will be marked down an *additional* 20% for the final 30 days.

CONSIGNOR AGREEMENT

- I authorize the store to set prices. I understand items will be declined if the min price I set is over the assessed value.
- I am responsible for picking up any unaccepted items within 7 days of notification.
- I agree to pick up unsold items within 7 days after the 120-day consignment period ends.
- Unclaimed items are donated after the deadline and cannot be returned or reimbursed.
